<u>UPDATE</u>: We have additional information about the existing gym floor, based on some input from a local flooring contractor who was involved during the design phase investigation:

The floor was originally designed and installed by a company based in Rochester called Webb Flooring. From the slab up, the system is composed of 1-3/8" thick softwood sleepers that are anchored in the concrete. In addition, the sleepers are typically set in roofing asphalt, and the roofing asphalt is poured in between the sleepers. The surface is nominal 1" thick beech strips laminated 3 to a plank, and the planks are tongued and grooved. The beech planks are blind nailed to the sleepers, and also laterally nailed to each other. It is quite robust.

The removal and disposal of the floor would normally be done with a Bobcat and cost around \$2/sf (approx. \$16,000). We spoke with Western NY Floors (company that helped during design phase and also a likely bidder) regarding potential salvage efforts and the costs escalate depending on a couple options:

Option 1: manually remove flooring with pry bars (fasteners remain as is – exposed) and place in storage container provided by District – ADD \$24,000 to the demo cost above (\$40k total).

Option 2: manually remove flooring with pry bars <u>and</u> associated fasteners and place in storage container provided by District – ADD \$8,000-\$32,000 to the option 1 cost above (\$48-80k total).

As you can see, there's quite a range associated with removing the fasteners, given the unknowns that can't be determined until the work starts and progress can be gauged. It will be difficult for bidders to quantify their efforts based on a walk-through as the critical item is the fasteners which cannot be seen and how smoothly removal occurs.

The current bid documents direct the GC to remove and dispose of the flooring at their discretion. There is no salvage provision required based on the research and associated cost for and time involved in careful removal. The Wildcat in the center of the floor will be preserved.

As for the bleachers, we believe the wood to be Southern Yellow Pine and have issued direction (via addendum) to bidders to disassemble full wooden planks (do not cut into smaller pieces) from the bleacher support structure and place in a storage container (provided by District) in the parking lot adjacent to the Gym. This wood will be excessed and will be available for reclaiming. An action to excess the bleacher wood is included on the June 11 agenda.
