## SUPERINTENDENT'S REPORT Board of Education Meeting March 9, 2020

**3.e.1. TJC Summer Reading Camp.** During the summer of 2019, we launched a reading opportunity for students at T. J. Connor. The results for the experience were positive for students, with all students either remaining at the same reading levels or increasing. We continue to monitor the students who engaged in this intervention to assess their progress.

Given the success in 2019, we wish to plan for a Summer Reading Camp in 2020. The following are details of the Camp:

**Target Group:** Up to 40 students who have just finished grades K-5. [Targeting K-3 population more (poor attendance last year with 4<sup>th</sup> and 5<sup>th</sup> graders)].

**Criteria for Selection of Students and Data Collection:** Already receiving reading intervention support, identified through CSE/CPSE, low reading level as per STAR and/or Next Steps to Guided Reading (NSGR), teacher recommendation, parent recommendation. June NSGR data will be used as the pre-assessment. A post-assessment using NSGR will be given at the end of the program in August. The goal of the program is to maintain or improve reading levels as shown through the NSGR data. Scholastic "Lit Camp" curricular resources will be used for instruction.

**Days/Times/Location:** Tuesdays, Wednesdays, and Thursdays from 8:30 a.m. to 10:00 a.m. for five weeks (July 14, 2020 – August 13, 2020) at T. J. Connor.

**Transportation:** Buses to transport students to TJC for an 8:30 a.m. start time and a 10:00 a.m. dismissal time. For students who attend Wheatland Recreation summer camp, the bus will make a stop there. Walkers and car riders are also welcome.

**Budget:** Estimated amount of \$4,320, covering the total staffing cost for four teachers paid at their hourly rate. Included in this amount is a half-hour planning time each day, plus two planning days before and after the program starts/ends.

In order to meet timelines for public notice and required communications efforts, the Board will review and vote on the 2020-2021 budget on Tuesday, April 14, 2020.
