CALL TO ORDER –President K. Snyder called the meeting to order at 7:01 p.m.

PRESENTATIONS/REPORTS/DISCUSSIONS

- a. <u>Curriculum Update</u> J. Sinsebox provided an update on work that is occurring in the areas of curriculum and data management. This included updates on math coaches, reading and literacy work, a new music first program, and new science standards.
- b. <u>Update on School Improvement Process</u> J. Sinsebox provided a quarterly update on the school improvement process and the Greatest Areas of Need (GAN) based on the Plan-Do-Study-Act process. Each grade level or subject area reviewed their GAN, action steps, and measures completed to identify follow-up actions. An overview was provided to the Board members.

c. Superintendent's Report - D. Leh

- 1) <u>Senior Holiday Tea</u> D. Leh reminded the Board of the upcoming senior holiday tea being held on Thursday, December 22 at 1:30 p.m. An Alumni Basketball game is being held immediately following the game.
- 2) <u>Updates from December 5 Board of Education Meeting</u> D. Leh reviewed questions from the last Board meeting which included the Board's midyear review of priorities, the amount of the pupil transportation budget increase, interscholastic fundraisers, the soccer banquet, signage at the MS/HS, and painting in the MS/HS gym.
- 3) <u>Elementary Grade Configuration Ad Hoc Committee Progress</u> D. Leh shared educational research and review work that has been completed by the Ad Hoc Committee on elementary configurations. The work

of the Committee will continue in January with a recommendation to the Board scheduled for January 23, 2017.

- 4) <u>Capital Project Committee Planning</u> D. Leh reviewed a list of suggested committee members to participate on the Capital Project Planning Committee. Other stakeholder groups and community members will be encouraged to participate. Meetings will begin in January.
- 5) Communication Plan on Social and Emotional Learning Efforts D. Leh shared information with the Board on steps the District has been taking to address the need for behavioral interventions at the elementary and secondary levels to support children. A summary of work that has occurred in this regard includes training, student support, planning, and exploration of further resources and actions. A letter is being prepared to send out to parents to provide transparency, while still maintaining confidentiality, on work that is being done.
