PRESENTATIONS/REPORTS/DISCUSSIONS

- a. <u>Budget Presentation 2017-2018</u>: <u>Staffing and Enrollment Projections</u> D. Leh reviewed the first budget presentation of the 2017-2018 budget season which presented an overview on staffing and enrollment projections. Projections on the tax levy limit increase are expected to be around 0.75% and state aid is anticipated to increase 2.5%. Expense and revenue variables were reviewed and compared to this year. Class size considerations will continue to be discussed and staff assignments will be explored. The leadership team will begin assisting in the development of a draft budget.
- b. <u>Capital Outlay Project</u> J. Smith provided a brief overview of the potential inclusion of a capital outlay project in the 2017-2018 budget. In order for the District to avail itself of capital project aid, the project must be under \$100,000 in scope. Aid is then returned to the District the following year. Districts utilize this mechanism to obtain capital project aid on work that exceeds normal facilities/maintenance work, and can be completed within a school-year cycle. Future potential capital projects and financing were also discussed.

c. Superintendent's Report – D. Leh

- 1) <u>Updates from November 21 Board of Education Meeting</u> D. Leh reviewed questions from the last Board meeting which included information on the District's liability for the Team of One, and insurance implications for the HS musical involving the use of rigging equipment for the production of Peter Pan.
- 2) <u>Substitute Teacher Rates</u> D. Leh shared data related to the substitute teacher rates throughout the state. The District's cost for substitutes and the additional cost for a rate increase was compared. A recommendation is being made to increase the daily substitute rate, the long term daily substitute rate, and the contract substitute rate.

- 3) <u>Holiday Concerts</u> D. Leh shared the dates of the upcoming holiday concerts at each level. A change in location for the elementary concert was noted.
- 4) <u>Mid-Year Review of Board of Education Priorities</u> D. Leh reminded the Board of the tentative date of January 17, 2017 for the mid-year Board workshop to review priorities.
- 5) Final 2016-2017 Tax Surrender D. Leh shared the final tax surrender information for 2016-2017.
