CALL TO ORDER – President K. Snyder called the meeting to order at 7:00 p.m.

It is a statement of endorsement by which the Board entrusts the wellbeing of its schools as institutions, and its most precious charges, its students, to the continued influence of the individuals it collects in the recruitment, hiring and retention process.

The Varsity Girls' Softball coach gave the Board information regarding a team field trip being requested for April, 2018.

TREASURER'S REPORT – The Board received the Treasurer's Report for May, 2017.

PRESENTATIONS/REPORTS/DISCUSSIONS

- a. Year-end Reports from Secondary and Elementary School M. Wright reviewed year-end events such as: DARE graduation, 24 Challenge, field day, and fifth-grade moving-up day. E. Windover reviewed year-end events at the secondary level such as: trip to Philadelphia, PA, art show, concerts, awards ceremonies, prom, senior recognition, and graduation.
 - A video of events from both buildings was shown.
- b. <u>Update on Curriculum</u> J. Sinsebox updated the Board on ELA curriculum work being done. K-5 has completed the Social Studies framework and is now working on the Math scope and sequence. Teachers are engaging in collaborative work at Monroe 2-Orleans BOCES on the Science curriculum. At the MS/HS level, Math teachers are working with BOCES on the scope and sequence. Other areas of curricular focus during summer 2017 are: ELA, Physical Education, Health, Business, Art, and Family and Consumer Science.
- c. Olweus Update K. Murray provided an update on work that is occurring in the District on our Olweus Bullying Prevention program. The work has been aligned this year with the Wildcat Ways. Surveys were administered in 2014-15, 2015-16, and 2016-17. Data from these surveys were reviewed.
- d. Superintendent's Report Dr. D. Leh
 - 1) <u>Updates from June 12, 2017 Board Meeting</u> D. Leh updated the Board on the Varsity Softball Team trip, a question regarding student injury reporting, and inclusion of a softball field scoreboard in the capital project that is under discussion.
 - 2) <u>Graduation and Graduate Newsletter</u> D. Leh commented on the Graduation ceremony and the upcoming edition of the print newsletter which will feature this year's graduates.
 - 3) <u>Status of Reserve Funds</u> D. Leh reviewed the preliminary status of reserve funds and the recommendations for fund balance and reserve allocations based on assessment of our year-end financials.
 - 4) <u>Board of Education Priorities</u> D. Leh presented a first draft of board priorities for 2017-2018 that was established at the Board workshop. A new priority for Social and Emotional Learning was created. The Board members will provide feedback on the draft.
 - 5) <u>Update on Hiring Process for Assistant Principal</u> D. Leh updated the Board on the status of the hiring process for the assistant principal. The paper screening of all applicants has occurred. Ten candidates will be interviewed by the Leadership team. Four to six candidates will be forwarded for interview by a District stakeholder group. It is anticipated that a finalist will be recommended to the Board at the July 24, 2017 meeting.

- 1) <u>June 21 Board Workshop</u> K. Snyder commented on the workshop and the topics discussed and priorities that were set. The Board will provide additional feedback on the priorities.
- 2) <u>Communications and Engagement Committee Update</u> M. Rocha commented on the recent meeting which covered the surveys sent out this spring and a climate survey planned for the fall. Talking points for social and emotional learning were also discussed.
- 3) <u>Financial Committee Meeting</u> K. Snyder and J. Musshafen commented on the meeting that reviewed use of reserves and the capital project.
 - 4) <u>Safety Committee Update</u> S. Fraser was unable to attend but will share the minutes when available.
 - 5) Other Items of Information S. Fraser spoke of her participation on the District Comprehensive Improvement Planning Committee related to parent communication and engagement.
 - S. Fraser also commented on the Etta Fraser Miller Scholarship selection process. There will be a brief meeting at 6:30 p.m. on July 24, 2017 to discuss revising the selection process.
 - J. Musshafen commented on the Year-End Staff breakfast.
 - J. Musshafen recognized and thanked K. Snyder for her twelve years of service and many contributions to the Board and community.
