TREASURER'S REPORT – The Board received the Treasurer's Report for June, 2014 (pre-audit).

PRESENTATIONS/REPORTS/DISCUSSIONS

- a. Superintendent's Report Dr. D. Leh
 - 1) Tax Rates for 2014-2015 D. Leh shared the tax rates that have been established for 2014-2015. The actual tax rate is lower than anticipated based on increased assessed values of Chili and Wheatland properties and the change in the equalization rate in Brighton. This reflects an average tax rate of \$23.39 per \$1,000 of full property values.
 - 2) <u>2014-2015 Board of Education Meeting Presentations</u>– D. Leh shared a draft schedule of Board meeting presentations for 2014-15. Board members were asked for their feedback.
 - 3) Wheatland Community Night, September 17 D. Leh updated the Board on the upcoming Wheatland Community Night being held on September 17, 2014. In the past this was usually held on Thursday evening but this year, it has been changed to a Wednesday evening. A discussion occurred around the Board's interest in participating this year.
 - 4) <u>Superintendent's Conference Days</u> D. Leh reviewed the agendas for August 28 for teaching staff and September 2 for all staff.
 - 5) Superintendent's Goals 2014-2015 D. Leh shared a draft of the Superintendent's goals for 2014-15, which are aligned with the Board priorities. The goals will be brought for information to the September 8 Board meeting with any feedback.

- 6) NYS Grades 3-8 Assessments in ELA and Math D. Leh reviewed the released data for the 3-8 ELA and Math Assessments. The data were compared to results from previous years. The results were stronger in Math. The district is planning a strong focus on literacy this year.
- 7) <u>Capital Project Update</u> D. Leh presented an update on construction, and on the closing of the Bond Anticipation Notes. Pike Construction will present an update at the September meeting.
- 8) Middle States Accreditation Update D. Leh gave a brief overview of the upcoming Middle States Candidacy Visit on September 16, 2014. The schedule that day begins with a meeting with Board members at 7:45 a.m. Board members discussed who would be available to attend.

RESOLUTION OF THE BOARD OF EDUCATION OF THE WHEATLAND-CHILI CENTRAL SCHOOL DISTRICT, LIVINGSTON AND MONROE COUNTIES, NEW YORK (THE "DISTRICT") AUTHORIZING AND ADOPTING POST ISSUANCE COMPLIANCE POLICIES AND PROCEDURES RELATED TO THE DISTRICT'S TAXEXEMPT OBLIGATIONS, SUCH POLICIES AND PROCEDURES INTENDED TO ENSURE THAT THE REQUIREMENTS IMPOSED UPON THE DISTRICT PURSUANT TO THE INTERNAL REVENUE CODE OF 1986, AS AMENDED, WILL BE SATISFIED

WHEREAS, the Wheatland-Chili Central School District, Livingston and Monroe Counties, New York (the "District") previously has issued bond and notes (the "Tax-Exempt Obligations"), the interest on which is excluded from gross income of the owners thereof pursuant to Section 103 of the Internal Revenue Code of 1986, as amended (the "Code"); and

WHEREAS, the District intends to issue additional series of Tax-Exempt Obligations in the future; and

WHEREAS, in order to ensure that that interest on District's Tax-Exempt Obligations will continue to be excluded from gross income of the owners thereof for purposes of federal income taxation, and that the District complies with its tax certifications relating to the Tax-Exempt Obligations, the Board of Education has determined, based on the advice of the District's Bond Counsel, to adopt certain written Post-Issuance Compliance Policies and Procedures in the form attached hereto as Exhibit A and made a part hereof (the "Post-Issuance Compliance Procedures").

NOW, THEREFORE, BE IT RESOLVED by the Board of Education of the Wheatland-Chili Central School District, Livingston and Monroe Counties, New York (the "Board"), as follows:

Section 1. The Board hereby approves and adopts the Post-Issuance Compliance Procedures.

Section 2. The Board hereby appoints the Superintendent of the District to serve as the "Designated Tax Compliance Official" under the Post-Issuance Compliance Procedures and hereby authorizes and directs the Superintendent, acting in such capacity, to take such actions, after appropriate consultation with Bond Counsel to the District, as the Superintendent deems necessary, appropriate or desirable to effect the implementation of the Post Issuance Compliance Procedures, and hereby further authorizes the Superintendent, as such Designated Tax Compliance Official, to delegate to such other District officials or employees as the Superintendent shall determine is necessary or appropriate, the responsibility to take certain specific actions called for by the Post-Issuance Compliance Procedures.

Section 3. This Resolution shall take effect immediately.
